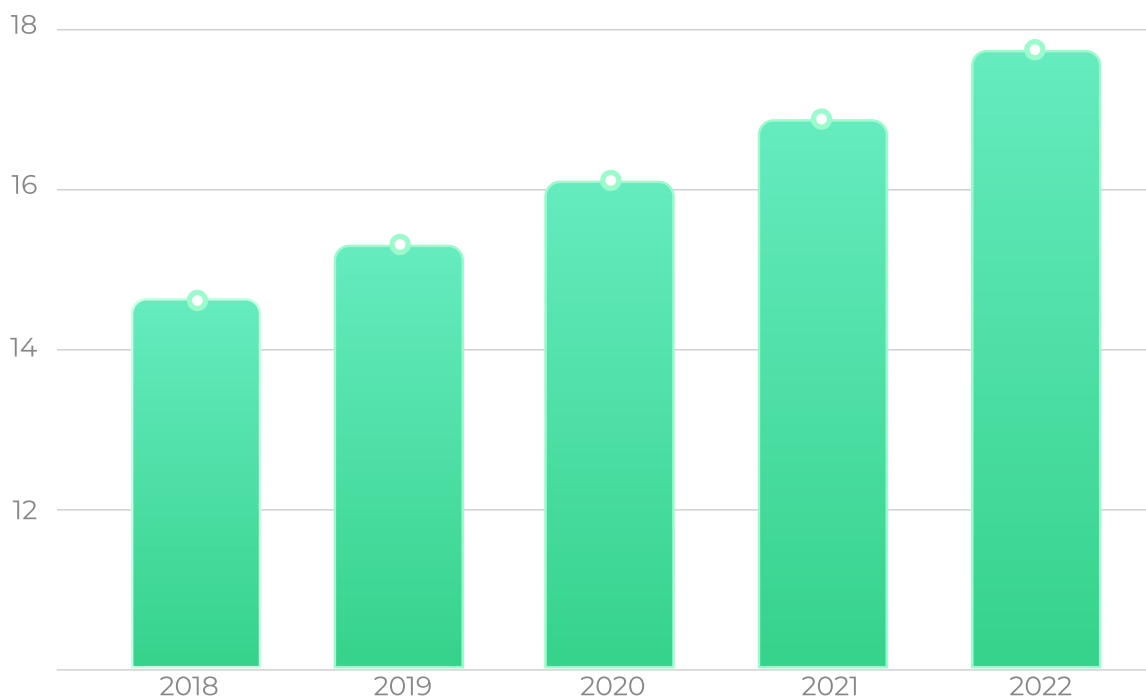

Hinto is a next-generation platform for online sports betting tips, which uses techniques such as Big Data and Machine Learning to predict the outcomes of sports events (football, tennis etc.) with greater accuracy than ever before. Between April 2018 and December 2019, the platform's tips generated an average monthly Return on Investment (ROI) of 10.97%. Access to Hinto betting tips is available through one of three subscription plans: Basic, Premium, and VIP. The Hinto Token is an ERC20 utility token that can be used to purchase the Basic plan at a 50% discount, Premium at a 30% and VIP at 34%

Introduction

The online sports betting industry has taken the world by storm in recent years. In the UK alone, there are over 30 million active online betting accounts, with a shared balance of around £780 million (\$977 million). Football is by far the most popular sport for UK bettors, generating £1 billion (\$1.27 billion) in annual revenue for bookmakers.

Importantly, the industry is growing. According to a 2018 report, the complete UK gambling market — including the online sports betting market — is expected to grow at a Compound Annual Growth Rate of 5.16% until 2022. With this, we can expect the UK's annual gross gambling yield to grow to almost £18 billion within the coming year.

Betting Tips

All bettors share one thing in common: they want to maximise their winnings. This has led to the rise of betting tips — expert predictions on which team is most likely to win a sports match — as well as various books and courses on betting strategy. Betting tips are particularly popular among amateur bettors, since little effort is required to use them.

While individual betting tips can often be found free of charge, access to regular betting tips can cost as much as £850 a month. Generally speaking, both free and paid tips can provide the slight edge needed to turn a profit with sports betting. However, amateur bettors often overlook the fact that successful sports betting is as much about risk management as it is

choosing the most favourable team. As a result, bettors end up risking large amounts of their bankroll on individual bets, without any knowledge of which tips the expert is most confident in, thus resulting in poor overall performance.

Addiction

Despite almost 95% of bettors losing money with sports betting, many continue to do so. Oftentimes, the reasons for continued betting are innocent; for example, the bettor simply enjoys gambling, and makes sure to do so with insignificant amounts. As such, sports betting remains a controlled habit with little negative effect on the bettor's life.

Unfortunately, the issue of addiction is quickly growing in the online sports betting sector. A gambling addiction can quickly ruin an individual's finances, subsequently detracting from other areas of life such as work and interpersonal relationships. At present, almost 7% of UK bettors are at risk of addiction, and there are few solutions.

What Is Hinto?

Hinto provides smart betting tips for sport events (football, tennis etc.) through an easy- to-use web interface. Instead of relying on human analysis to create betting tips, our platform uses powerful mathematical algorithms to analyze tens of thousands of past league matches, generating some of the world's most accurate tips. Unlike other distributors of betting tips, the Hinto platform

ells users exactly how much to bet on each match, crucially minimising the risk of individual bets.

The Hinto algorithm isn't right 100% of the time. However, the exceptional accuracy of our platform is unheard-of, even among professional bettors. From a total of 1777 betting tips published between April 2018 and December 2020. That period, users who bet according to our tips generated an average monthly ROI of 10,97%. Without reinvesting any profits in their bankroll, this equates to an annual ROI of 230,41%.

Interface

Hinto.win is the web interface that gives users access to the Hinto platform. The interface is divided across two main pages: the Matches page, and the Tips History page. The former shows users current betting tips for upcoming sports matches, while the latter documents previous Hinto tips and their accuracy.

Using Hinto is extremely straightforward. Here's how a beginner can get started with Hinto in just three easy steps:

1. Sign Up

Hinto only shares betting tips with registered users, so the first step is to sign up. Users can gain up to two weeks of free betting tips with a Trial account, after which they can upgrade to a Basic account for just £9,99 per month. The Basic plan gives users access to all of the Hinto platform's betting tips (the same betting tips which have historically generated a monthly ROI of 10,97%).

2. View Tips

After signing up, users can see all of the day's betting tips by navigating to the Matches page. On this page, users can see exactly what bet to place on any given match and how much to bet.

Hinto betting tips either predict the number of goals that will be scored in a given match, or the overall outcome of the match. Based on this, betting tips can be provided in one of two formats.

For goal-related tips, the following format is used:

Tip	
under 0.5	No goals
under 1.5	Less than or exactly 1 goal
under 2.5	Less than or exactly 2 goals
under 3.5	Less than or exactly 3 goals
under 4.5	Less than or exactly 4 goals
over 0.5	More than or exactly 1 goal
over 1.5	More than or exactly 2 goals
over 2.5	More than or exactly 3 goals
over 3.5	More than or exactly 4 goals

For outcome-related tips, the following format is used:

Tip	
1X	Home team wins or draws
1X2	Home or away team wins
X2	Away team wins or draws
1	Home team wins
X	Draw
2	Away team wins
DRAW NO BET	Given team wins; the money is returned if the match is drawn

3. Place Bets

Hinto itself only provides betting tips, so users must manually place bets themselves on a third party betting platform. While any platform can be used to place bets, Hinto works best with Betfair, one of the UK's most popular sports betting websites.

How it works

The Hinto algorithm uses advanced Big Data and Machine Learning techniques to identify individual patterns and trends in tens of thousands of historical sports matches. Based on this, the algorithm is able to generate quantitative performance ratings and goal-scoring tendencies for all teams. By analyzing this data against the matchups of upcoming games, the Hinto algorithm can predict the number of goals that will be scored in a game or its overall outcome. After accounting for the betting odds set by the bookmaker (Betfair), the Hinto platform can then identify and publish profitable betting opportunities to its users.

For each prediction, the Hinto algorithm takes into account data points such as:

- Previous outcomes of that exact matchup
- Historical performances of both teams
- Recent performances of both teams
- Average number of goals scored by both teams
- Betting odds set by the bookmaker (Betfair)

As alluded to earlier, an essential element of profitable sports betting is bankroll management. Since there is no way for the Hinto algorithm to ensure 100% accuracy for any given tip, only small amounts of a user's bankroll should be bet on each match. The Hinto platform tells users exactly how much to bet based on the size of their bankroll and a confidence rating specific to each tip. For example, if a tip is based on strong, well-defined patterns, the tip will have a high confidence rating and the Hinto platform will suggest a larger bet. If a tip is based on weaker patterns, the tip will have a low confidence rating and the Hinto platform will suggest a smaller bet.

Also of note, after each match finishes, new data is fed back into the Hinto platform. This allows the Hinto algorithm to autonomously learn from both its successes and its mistakes, while continually contributing to the data sets it draws predictions from.

Introducing The Hinto Token

The Hinto ecosystem will be powered by the Hinto Token (HNT), a utility token that can be redeemed for access to the Hinto platform.

Utility

The Hinto Token can be used to purchase membership plans on the Hinto platform. In addition to offering new and existing users a 50% discount on the Basic plan, 30% Premium and 34% for VIP plans.

The table below shows monthly membership costs for the three plans, when paying with GBP versus when paying with the Hinto Token:

Users can load Hinto Tokens onto their account by sending tokens to the public address listed in the Profile section of the Hinto.win web interface or Hinto mobile applications.

Specifications

The Hinto Token is an ERC20 token. This means it can be transferred between and stored within regular Ethereum (ETH) cryptocurrency wallets.

The maximum supply of the Hinto Token is 1,000,000 HNT.

Initial Exchange Offering and Airdrops

90% of Hinto Tokens will be distributed by means of one or more Initial Exchange Offerings (IEOs). The remaining 10% of Hinto Tokens will be used for promotional airdrops.

Future Development

We have numerous ideas for the future development of the Hinto ecosystem:

ICO and development of verifiable tip history (Q3 2019)

Whenever a new tip is published on the Hinto platform, we plan to automatically share an encrypted copy of that tip on the Ethereum blockchain. Upon signing up for any of our three plans, users will receive a private key which they can use to decrypt the tips.

Since all blockchain entries are timestamped, this will allow users to check that past betting tips were indeed made before matches began. As such, users will be able to place full faith in the past performance of the Hinto platform before putting their own money on the line.

Technological development and improvements of whole

We are currently working on the technological development of the platform in such a way that the operation is fully optimised and maximally user-friendly. We plan to add a new interface for the user panel that will facilitate the use of the hinto service and provide more pleasant experience during use.

Create an affiliating program for users (Q2 2020)

The Hinto Affiliate Program will introduce a new way for users to earn money within the Hinto ecosystem. Each user of the Hinto platform will receive a unique affiliate link which can be shared with others. When a new user subscribes to one of Hinto's three membership plans using an affiliate link, the referring user will receive a monthly commission in Hinto Tokens for as long as the new subscription is upheld.

The size of these commissions will correspond to the number of referrals a user generates:

- For the first 5 referrals, the user will receive a 10% commission
- For referrals 6 through 50, the user will receive a 15% commission
- For any additional referrals, the user will receive a 20% commission

Further improvement of the Hinto algorithm (Q3...2020)

Aside from further development of the Hinto ecosystem, we plan to continuously improve the Hinto algorithm itself. This will involve reviewing the past performance of the algorithm to evaluate potential areas of improvement. Periodically, we will make updates to a private testing algorithm, and, if they are successful, roll these changes out to the live Hinto algorithm.

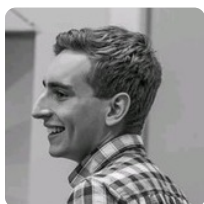

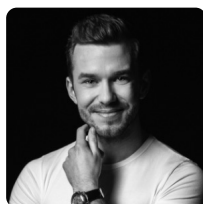
